



**August 2-3, 2008 • Northeastern Ohio**

The 2nd Annual Burning River 100 is an exciting 100 mile run held in Northeast Ohio that travels through several of the region's most scenic areas, including the Cuyahoga Valley National Park, the Cleveland Metroparks and the Metro Parks serving Summit County. Starting at Squire's Castle in Willoughby Hills, the run follows the scenic Cuyahoga River Valley Corridor and finishes in Cuyahoga Falls.

**Start:** 5:00am, Saturday, August 2; Squire's Castle, Cleveland Metroparks, Willoughby Hills, OH

**Time Limit:** 30 hours; Sunday, August 3rd 11:00am

**Finish:** Falls River Square, Front St and Broad Blvd., Cuyahoga Falls, OH 44221

**Aid Stations:** Approximately every 5 miles. It is strongly urged all runners carry at least one water bottle during the race!

**Course Description:** Point-to-point; 75% trails and 25% towpath or roads.

**Transportation to the Start:** Available on the morning of race (from Finish location to Start location) by pre-registration only for an additional fee of \$10 per Runner. Runners are not permitted to park cars at the Start for the duration of race. Cars left after start will be towed by order of Cleveland Metroparks at the owner's expense.

**Awards:** will be awarded to Overall Male and Female 1st, 2nd and 3rd, Overall Masters and Grand Masters. No duplicate awards.

**Limited to 250 Entrants**

**Fee:** **\$150 if postmarked by December 31, 2007**  
**\$175 if postmarked by May 31, 2008**  
**\$200 if postmarked by June 30, 2008**  
**\$225 thereafter**

*Refund Policy: For refund requests postmarked by May 31, 2008 an administrative fee of \$25 will be deducted. No refunds after May 31, 2008.*

**Fee Includes:** Technical shirt, 1 pre-race pasta meal, stocked aid stations, finisher's award, 1 post-race breakfast buffet.
